

Bound and Determined

When a young CASA teen found himself in juvenile court for a second time due to a neglectful parent, he knew he would have at least one person he could count on.

Adopted as a toddler, this young boy was placed in the state's care at 10 years old when his adoptive mother's mental illness triggered a neglect finding. He met with his CASA volunteer for the first time at the court house. Less than a year later the case was closed, but that's not the end of his story. Two years later he was removed from home again and placed in a group home.

There was no question his CASA would take his case again. The CASA knew his history and his dreams. For six years, his CASA has been his voice in court. The volunteer proudly attended his high school graduation this spring. This young man says when he needs someone to talk to, he knows just who to call. He credits his CASA volunteer for being a strong and consistent support as he prepares for his next chapter:


199,836 miles were traveled by volunteers





Court Appointed Special Advocates or CASA programs recruit, screen, train and support volunteers. Those volunteers are appointed by Judges to be the voice of abused and neglected children who have been removed from their homes due to abuse and neglect.

1,158 Children Served by 412 Volunteers in 2010



1,968 Children Served by 849 Volunteers in 2017



- ⇒ 21 CASA programs serve 47 counties
- ⇒ CASA programs in Nebraska operate in compliance with the Nebraska Court Appointed Special Advocate Act (Nebraska Revised Statutes § 43-3701 et seq.)
- A child with a CASA volunteer is more likely to find a safe, permanent home and have a consistent and responsible adult presence.
- ⇒ A child with a CASA volunteer is more likely to do better in school and spend less time in foster care.
- 2,000 children are in the Foster Care system without a CASA volunteer.
- ⇒ Nebraska CASA Programs served 1,968 children in 2017 or 70% more children than 2010.
- ⇒ 849 CASA volunteers advocated for abused and neglected children in 2017. This is a 106% growth in volunteers in 7 years!

If every Foster child had a CASA volunteer, a conservative cost savings based on services provided to the child's family is \$30 million to the state of Nebraska.

(Estimate does not include state personnel costs for DHHS or court costs.)
