Keith County CASA hosted its inaugural "Children Are Our Future" Benefit Inservice on April 4 in the West Winds Golf Club clubhouse. Hot hors d'oeuvres and beverages were served to the 80 attendees during the Silent Auction, followed by our eloquent speaker, Kim Rask. The benefit raised \$7,181.00 from ticket and silent auction sales, as well as from free-will donations and in-kind services.

Our featured speaker for the in-service was Kimberly Rask, a former social worker and child abuse investigator, who spent a total of 15 years in the field. Rask has previous experience working in the nonprofit field, during which she helped develop and maintain successful outreach programs. Kim provided insight on surviving and thriving after childhood abuse and trauma.

In the afternoon, Kim presented an interactive program for the families of children with Native American heritage. She entertained with folk takes, legends and games from her background, integrated with recipes, ceremonies and religious beliefs.
